**APPLICATION AGREEMENT:**

1. TIFAF is a strictly vetted fair. There is no dateline for this fair. All applicants agree to abide by all Vetting Rules as may be set forth by TIFAF and the subsequent decisions of the Vetting Committee with regard to all proposed exhibitions at TIFAF.

2. Included in the booth cost will be wall-to-wall carpeting, 10'-high hardwall dividers as per fair regulations and standard allocations, exhibition sign, drayage for regular artwork and a catalogue. There are mandatory additional fees for booth lighting, required booth decoration, wall covering, and TIFAF advertising. Extra walls, special walls, walls higher than 10', custom flooring, booth trim, additional signage, furniture, custom drapery, shelving, closets, sculpture pedestals, sculpture drayage, and labor furnished for exhibitor supplied materials are available at additional charge.

3. This Exhibitor Application, completed in its entirety, accompanied by the appropriate deposit shall only constitute an application for exhibit space in TIFAF. It is subject to review and approval by the TIFAF organizers who reserve the right to reject any applicant for any reason. All applications will be accepted or declined only in writing by TIFAF and such decisions are at the sole discretion of TIFAF. There exists no obligation by TIFAF to any applicant until a completely executed Exhibitor's Agreement has been signed by both applicant and TIFAF.

4. Deposit requirements: Please remit US\$2,500 with this application. U.S. checks should be made payable to IFAE, L.L.C. Overseas telegraphic transactions should be made in U.S. dollars to: Gulf Stream Business Bank, Stuart, Florida. ABA#0670-14712 to credit the account of IFAE, L.L.C., Account #0150005981. Please include gallery name to ensure proper credit. No space will be reserved without a deposit. Deposits are non-refundable unless the application is declined by TIFAF or the show is cancelled for any reason. If TIFAF is unable to accept your application, a full refund will be issued.

5. Each applicant shall execute an Exhibitor's Agreement, which contains all rules and regulations pertaining to this exhibition within 30 days of receipt of written acceptance to TIFAF. Exhibitor Agreements are not subject to cancellation or modification after execution and countersignature, except by mutual written agreement. Failure to return a signed Exhibitor's Agreement within 30 days of acceptance will result in a forfeiture of the previously furnished application deposit.

6. All Exhibitors agree to be bound unconditionally by the TIFAF guidelines.
